**IS CHRISTMAS NEXT?** - This past week it was announced that the city of Bloomington, Indiana has renamed Good Friday and Columbus Day as "Spring Holiday" and "Fall Holiday" to be more "inclusive". Mayor John Hamilton said the move would "better reflect cultural sensitivity in the workplace."

Bloomington city employees receive paid time off for Columbus Day and Good Friday. Columbus Day became a federal holiday in the United States in 1937 and celebrates the arrival of explorer Christopher Columbus in the Americas in 1492. The holiday falls on the second Monday of October. However, it has drawn significant opposition in recent times from those who regard Columbus's arrival as a prelude to centuries of oppression. – Diversity is a good thing, however it is a two way street, meaning that we respect people's traditions, including Good Friday and Columbus Day.

**ON DOWNS SYNDROME** – On November 10<sup>th</sup>, the [French ‘State Counsel’ rejected an appeal](#) made by people with Down syndrome, their families and allies to lift the ban on broadcasting the award winning “Dear Future Mom” video on French television. The ban was previously imposed by the French Broadcasting Council. The video features a number of young people with Downs syndrome from around the globe speaking about their lives. Their stories reflect today’s reality of living with Down syndrome and aims to reassure women who have received a prenatal diagnosis. Their message of hope takes away the fears and questions these women may have, often based on outdated stereotypes. The video was produced in 2014 to celebrate World Down Syndrome Day. A day created by Down Syndrome International and officially recognized by the United Nations for the promotion of the human rights of people with Down syndrome. The State Counsel said that allowing people with Down syndrome to smile was “inappropriate” because people’s expression of happiness was “likely to disturb the conscience of women who had lawfully made different personal life choices.” While studies from the United States and [the Netherlands](#) have shown that children with Downs syndrome are typically much happier than most people, this video is banned from public television because their happy faces make certain segments of the population feel uncomfortable. This helps to continue myth that society and medical professionals so often portray; that Down syndrome is a life of suffering, a burden to their family and society. Obviously, if the truth gets out that most people with Down syndrome are happy with their lives, society may start to question the systematic screening and deliberate mass elimination of babies prenatally diagnosed under the pretense of health-care and women’s rights. 96% of pregnancies that are diagnosed with Down syndrome are aborted in [France](#). Worldwide this number is estimated to be about 90%. To address this disturbing issue, Archbishop Joseph Kurtz of Louisville, offered some personal reflections that speak to the very heart of the matter. He writes, “I know that parents facing a prenatal diagnosis of Down Syndrome are frightened, and I can’t take away the fear and concern. But I can share with you my own experience of my brother, George, who was born with Downs syndrome. My engagement with my brother Georgie was not distant. When our mother died in 1989, I became his legal guardian, and at the age of 48, he came to live with me in the parish rectory in Pennsylvania and later moved with me when I was appointed Bishop of Knoxville, Tennessee. I remember well how George contributed to the life of the parish I was serving. He was a community builder par excellence. Two weeks had not gone by before he had given each person on the rectory staff a nickname. In the Old Testament, God gave Abram a new name to claim him as his own, and so Georgie quickly claimed us as part of his family. At the rectory, Georgie contributed in countless ways. Through a playful “boo,” an occasional hug, and a pat on the back, Georgie brought to the rectory an

ease that became infectious. He became a valued co-worker and was greatly missed whenever he would take a vacation. He was a friend in the evening, and I learned the television schedules for most evenings after 9:30 PM. His gentle presence forced me to take the time to stop, pause, and enjoy. I quickly learned how much he was giving to me and to all he encountered. He comforted me after a tough day, responded to my grief at the death of our mother, and helped me to keep things in perspective. Giving and receiving are intertwined, and we never do one exclusively. In the case of my relating to my brother, it is not a cliché to say I received much more than I ever gave. The gift of my brother overflowed with a cornucopia of concrete acts of love and because of him, I am a better person. – We would do well to watch the short video and pray for those who have a child (in the womb or otherwise) who has Downs syndrome.
