**ADMINISTRATIVE CHANGES** – Back in the fall a review of our parish was conducted by the human resource director of the diocese. Such reviews are common practice and are being conducted throughout the parishes of the diocese. At the conclusion of the review suggestions from the human resources director were to restructure the office staffing and create new positions to fulfill responsibilities more efficiently based upon the specific needs of the parish as it is at present. I (Fr. Aron) have agreed with these recommendations and after receiving the unanimous approval of the parish finance council have decided to implement the changes. As a result of this both clerical positions at the parish will be eliminated, the last day being February 22<sup>nd</sup>. The parish now has openings for two new positions – Part-Time Housekeeper (18 hours per week) and Part-Time Administrative Assistant (27 hours per week). **TRUE EVIL IN NEW YORK** - A pro-life obstetrician-gynecologist is speaking out against New York passing a law this week to enshrine a "fundamental right" to abortion and strip protections from preborn babies until birth, warning that the move will have grave consequences for the character of the state and the nation. Dr. William Lile, a board-certified OB/GYN and pro-life public speaker who maintains the ProLifeDoc website, said that modern medical technology is already giving preborn babies blood transfusions, heart surgery, and more. "If they're a patient they're a person, and if they are a person they deserve our protection," he said in a YouTube video released recently. Dr. Lile emphasized that abortion-on-demand has nothing to do with sound medical practice. "I've been in private practice almost 20 years and I've delivered almost 4,000 babies with two primary rules: we want to have a healthy mom and we want to have a healthy baby," he said. New York's state Senate voted 38-24 and the state Assembly 92-47 in favor of the so-called "Reproductive Health Act." Democrat Gov. Andrew Cuomo, who signed the bill, called it a "historic victory for New Yorkers and our progressive values" and ordered the One World Trade Center spire to be lit in pink to mark the occasion. The bill declares that "Every individual who becomes pregnant has the fundamental right to choose to carry the pregnancy to term, to give birth to a child, or to have an abortion," erases the state's recognition of preborn babies older than 24 weeks as potential homicide victims, removes abortion from the penal code entirely, and allows licensed health practitioners other than full doctors to commit abortions. The New York State Right to Life Committee warns that by declaring abortion a "fundamental right," it opens the door to invalidating "any limits on abortion" and "mandat[ing] that everyone take part in the culture of death"; prevent pregnant women whose babies are killed in violent attacks from seeing justice; and it will have the effect of "authorizing infanticide" by repealing the requirement that a second physician be on hand in the event that an attempted abortion past twenty weeks yields a live infant. Pro-life leaders and commentators across the nation have spoken out against the new law. Dr. Lile, who grew up in New Jersey, noted the cheers and smiles in the New York capitol building when the bill was passed. "Celebrating what? The governor just signed a law saying that we can take the lives of the babies in the womb up until their due date. That's nothing to celebrate," he said, noting that babies sometimes need to be delivered early but never killed in the process. "To take the lives of these babies in the womb breaks my heart. It is not good for us and is not good for America," he argued. By contrast, he referenced Florida lawmakers' introduction of legislation to protect preborn babies as soon as their heartbeats can be detected. "That is good; protecting the lives of the babies on the inside is a good thing, it is a virtuous thing," he said. "If America wants to stay great, America must continue to be that shining light on the hill and do good. Taking lives of the bab[ies]: not good. Protecting the lives of the bab[ies] and treating them as patients, as persons and protecting them: that is good. And, that's what we will stand up for and that's what we will fight for," he declared.

**BISHOP OFFERS APOLOGY** - Amid mounting pressure, Bishop Roger Joseph Foys of the Diocese of Covington issued a new statement Friday apologizing to a group of pro-life students the Diocese initially condemned over a confusing video from the March for Life. The Diocese was among those that condemned a group of Covington Catholic High School students after <u>reports claimed a video showed</u> them harassing an elderly Native American veteran at the March for Life last weekend. But additional extended video and firsthand accounts soon revealed the man, Nathan Phillips, was the one who waded into the group waiting for its bus and decided to beat a drum inches from student Nick Sandmann's face, and other adults who accompanied Phillips shouted racial taunts at the kids. The kids had been performing

school cheers in an attempt to drown out the harassment, and did not respond to adults' insults and abuse in kind. On January 19, the Covington Diocese and the high school issued a joint statement that the students' behavior was "opposed to the Church's teachings on the dignity and respect of the human person." The statement also suggested the students faced expulsion. After the original narrative fell apart, Foys issued a new statement stating that an "independent, third-party investigation is planned to begin this week" and that it was "important for us to gather the facts that will allow us to determine what corrective actions, if any, are appropriate."Late Friday afternoon, the Diocese of Covington released a new, more apologetic letter signed by Foys. "We are sorry that this situation has caused such disruption in the lives of so many. We apologize to anyone who has been offended in any way by either of our statements which were made with good will based on the information we had," Foys writes in the letter. "We should not have allowed ourselves to be bullied and pressured into making a statement prematurely, and we take full responsibility for it." "I especially apologize to Nicholas Sandmann and his family as well as to all CovCath families who have felt abandoned during this ordeal," he continues. "Nicholas unfortunately has become the face of these allegations based on video clips. This is not fair. It is not just." Foys expresses hope that the results of the investigation "will exonerate our students so that they can move forward with their lives." Covington parents have expressed concern that the investigation, which has not been called off, is seeking permission to interview their children and that they were barred from entering the school without an appointment while Foys met with the students this week.

**NO CATHOLICS ALLOWED -** Every now and then a closer or more distant blood relation of Britain's Queen becomes a Catholic, and in doing so is removed from the "line of succession." This is one of the last legal remnants of a system of anti-Catholic discrimination which once saw Catholics banned from living in London and becoming army officers, long after the bloody persecution of Catholics by the British ended. It means that however unlikely it might have been in any case, conversion to Catholicism washes off the theoretical possibility that you could become King or Queen of the United Kingdom. Recently, it was the turn of <u>Princess Alexandra of Hanover</u>, who at 19 has adopted the Catholic religion of her mother. Princess Alexandra is rather more closely related to the houses of Hanover and of Monaco than to Britain's House of Windsor. Somewhat closer to the British throne was Lord Nicholas Windsor, who was received into the Church in 2001. Catholics are excluded from the line of succession by the Act of Settlement of 1701; Britain's monarch is, after all, the Supreme Governor of the Church of England. Catholics are the Act's targets, because it was passed in the aftermath of the English Revolution of 1688 which saw the overthrow of the Catholic King James II.
